

THE SITUATION OF AGRO-FORESTRY-FISHERY (AFF) PRODUCT EXPORT FROM VIETNAM TO THE EU IN OCTOBER 2024



Trends of EU's agricultural products imports

According to European Commission, the EU imported 13.4 billion EUR of agricultural and food products in August 2024. This marked an 8% decline from July 2024 but a 23% increase compared to August 2023. Over the first eight months of 2024, import value is 111 billion EUR, increasing 3% from the same period in 2023.

Brazil remained the leading supplier of agricultural products to EU during this period. Meanwhile, imports from Côte d'Ivoire, Nigeria, and Tunisia grew notably due to rising cocoa and olive oil prices. Conversely, imports from Australia recorded the sharpest decline (-38%) both in volumes and prices of canola oil.

The EU's imports of coffee, tea, cocoa, and spices increased by 4.6

billion EUR (+33%) year-on-year, due to increasing price. Olive and olive oil imports also saw a significant growth, increasing by 654 million EUR (+93%) due to higher volumes and values. However, imports of oilseeds and protein crops fell by 1.9 billion EUR (-13%), while cereal imports declined by 1.6 billion EUR (-20%) for the same reason.

EU concerns about economic slowdown due to trade disputes with the USA

The EU economy is expected to grow by 1.3% in 2025, lower than previous estimate by 0.1%. In 2024, GDP growth is 0.8%, while inflation slightly decrease to 2.4% and about 2.1% in 2025, nearing the European Central Bank's target of 2%.



Key challenges include trade protection from the US. President Donald Trump's proposal to impose a 10% tariff on European goods, contributing to weaken exports and industry production. Germany will lose 1% of its GDP and will not achieve export value target of 25 billion EUR. Meanwhile, climate change also has negative impact on economic growth, such as devastating floods in Spain damaged infrastructure and driving higher inflation.

The EC also raised alarms over high public debt and fiscal deficits in some countries, particularly France. France's budget deficit is expected to decrease from 6.4% of GDP in 2024 to 5.3% in 2025, it may rise again beyond 2026.





Changes in percentage of export value to the EU, Oct-2024














TOP 5 export enterprises by value to the EU, Oct-2024

SPOTLIGHTS



Espresso is an integral part of Italian culture. In Italy, price of an espresso cup is only 1 EUR (approximately 0.83 GBP) at cafés, much cheaper than in countries like the UK (about 3.70 GBP). However, coffee prices in Italy are expected to increase due to a shortage of coffee bean supplies and global inflationary pressures.

Over the past year, coffee prices have increased by 48% and will continue to increase as climate change negatively effects on coffee production. Major coffee-producing countries such as Brazil and Vietnam are facing challenges due to unfavorable weather conditions.

Germany's coffee imports increase in the first eight months of 2024

According to data from the International Trade Centre (ITC), Germany imported 945.8 thousand tons of coffee with a value of 4.33 billion USD from global markets in the first eight months of 2024, increasing 7.1% in volume and 13.3% in value compared to the same period last year.

During this period, the average import price of coffee in Germany is about 4,573 USD/ton, marking a 5.7% year-on-year increase.





Changes in percentage of export value to the EU, Oct-2024










TOP 5 export enterprises by value to the EU, Oct-2024

EU and Norway agree on cod fishing quotas in Svalbard

The European Union (EU) and Norway have reached an agreement on cod fishing quotas for EU vessels in the Svalbard region starting in 2025, at 2.8274% of the Total Allowable Catch (TAC), equivalent to 9,217 tons annually. The agreement enables EU fishing vessels to continue to catch cod fishing in Svalbard and adjacent international areas. This agreement was achieved through the EU-Norway High-Level Dialogue, co-chaired by European Commission Vice-President Maroš Šefčovič and Norwegian Foreign Minister Espen Barth Eide to resolve longstanding disputes over fisheries management between the two parties.


EU terminates fishing agreement with Senegal


On November 12, the EU announced not to renew its fishing agreement with Senegal because of their concerns over weak management, leading to unsustainable fishing practices and negative impacts on local marine resources. Earlier in 2024, the EU considered Senegal as a "non-cooperating country" in the fight against illegal fishing. The African nation's measures are insufficient to ensure the sustainability of fish stocks. Following the agreement's termination, European vessels will leave Senegalese waters, and stop financial contributions.




Export value to the EU, Oct-2024








Percentage of export value to the EU, Oct-2024

SPOTLIGHTS

According to a report from the Finnish Natural Resources Institute (Luke), Finland's roundwood trade in October 2024 saw a remarkable increase, exceeding 50% compared to the five-year average. This growth marks a significant milestone in the forestry sector, reflecting market demand increase and effective forest resource management.

Cumulatively, in the first 10 months of 2024, the total volume of timber trade increased by 16% compared to the same period in 2023. This growth also surpassed the five-year average by 21%, highlighting the steady and robust development of Finland's timber industry.









In the first 10 months of 2024, Moldova's fresh grape exports to the EU is about 34.2 million USD (627 million Leu), almost 1.9 times higher than in the previous year. Romania and Poland are the largest importing countries. According to EU Parliament decision, Moldovan grape exporters fully access to the EU market, free from both tariff restrictions and quotas.

Spanish onion prices drop sharply due to 30% yield increase and low demand in Europe

Spain's onion planting area and yield increased by nearly 20% and 30% compared to the previous season, respectively. However, low demand from import markets has led to a sharp drop in Spanish onion prices.

The main reasons of price decrease is due to many new onion producers who started to plant onions this year without formal supply contracts with traders or importers. Additionally, they lack of technical expertise in producing, harvesting, and packaging leading to early harvests and poor planning, which negatively impacted the quality of the onions.









Export volume and value to the EU, Oct-2024









PEPPER

SPOTLIGHTS

According to Eurostat, in the first eight months of 2024, the EU imported 45,000 tons of pepper from non-EU countries, with value of nearly 216 million EUR (about 233 million USD), increasing 33% in volume and 50% in value compared to the same period in 2023.

Among the non-EU suppliers, Vietnam is the largest exporter of pepper to the EU, with a total export volume of 30,000 tons, valued at 138 million EUR (149 million USD). This represents a 42% increase in volume and a 67% increase in value compared to the first eight months of 2023. Vietnam's market share in the EU's total pepper imports from non-EU countries reached 66% in volume and 63% in value during this period.

The EU has issued Regulation (EU) 2024/2794, effective from November 7, 2024, to tighten the organic certification for imported products, including pepper from Vietnam. This regulation updates the list of organizations recognized by the EU to control and issue organic certifications, including Olska Spolka Z Ograniczona Odpowiedzialnoscia (VN-BIO-181), Onecert International Private Limited (VN-BIO-152), and SRS Certification GmbH (VN-BIO-195), for product groups such as plants, processed foods, and animal feed. This is a part of the EU's efforts to ensure the quality and transparency of imported organic products, creating an opportunity to boost Vietnamese pepper exports if these new regulations are well adhered to.







Export volume and value to the EU, Oct-2024

EUDR has a significant impact on global rubber production

Thailand, Vietnam, and Indonesia are the world's leading rubber producers. However, Côte d'Ivoire's rubber production is gradually catching up with Southeast Asian countries, thanks to efforts to meet the EUDR standards.

In 2023, Côte d'Ivoire produced 1.55 million tons of natural rubber, nearly double the amount produced in 2019 (815,000 tons), surpassing Vietnam to become the third-largest rubber producer in the world, after Thailand and Indonesia.

Rubber plantations in Côte d'Ivoire have benefited from implementing EUDR standards, as they have committed to reducing deforestation and have called on the European Union to increase financial support for rubber production.
